



## Application for Recording Review

**SUBMISSION(S) SENT IN FOR REVIEW WILL NOT BE RETURNED**

If accepted, the submission(s) will be eligible to be sold at TAMARACK: *The Best of West Virginia*. A preliminary test order is typical but, there is no guarantee there will be a purchase. Reorders may follow based on sales.

Submission(s) are reviewed and applicants are notified via phone or email.

Submissions must be a complete and finished product and shelf ready.

### *Criteria for the Review Process*

Tamarack is constantly seeking materials pursuant to our mission of providing opportunities for West Virginia writers, performers and musicians for the promotion of the "Best of West Virginia." All submissions *must meet* the following criteria:

- Single Artist – Current WV resident or WV native,
- Groups – 50% of members must be current WV residents or WV natives.

All materials must be available without minimum purchase requirements. It is your responsibility to provide and update information pertaining to the distributor or agent. Accepted submissions should be currently available for purchase. For out-of-print submissions, significant stock should be available and be in excellent condition.

Note: Juror will review content, production, and printing quality.

Submission(s) should be of high quality and professionally produced.

Canned music is only acceptable if it is minimal and in the background.

Majority of music should be "live" (in studio).

Submission(s) must be in an appropriate plastic case or an ecology minded cardboard case. Plain paper envelopes not acceptable.

Self-copied materials are not acceptable. Artwork should be appropriate.

Cover and back cover artwork should be pleasing to the eye.

Inside cover sleeve should contain biographical information and contain a list of songs with credits for the music.

Expect pricing to be reflective of store pricing.
